The limited review of financial results for the quarter and nine months ended December 31, 2024, as required under Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), has been completed by the Statutory Auditors and they have Issued an unmodified report on the aforesaid results.

The Hon'ble National Company Law Tribunal, Court IV, New Delhi Bench ("NCLT") has approved the Scheme vide its order dated January 01, 2025. The appointed date of the Scheme is April 01, 2024. The Scheme will be effective from the date of filing of the certified copy of NCLT order with the Registrar of Companies, NCT of Delhi & Haryana. Consequently, no impact of the Scheme has been given in the above financial results.
